- 2. Apologise were sent from Carson Albury, Colin Frampton and Jacqui Matten.
- 3. It was asked whether it was agreed that Hamble was agreed to be maintained by SBL, Mel informed partnership that Adur and Worthing District Council have not agreed to maintain Hamble. It was stated that SBL partnership had not agreed to maintain as lack of volunteers.
 - Trevor gave update on Broadband, prices on upgrade from Utility warehouse and BT had been acquired and Virgin Media had been contacted for a price.
 - Gill and Barbara approved and seconded minutes subject to the changes.
- 4. Chair updated partnership that Sompting Football Club had received their grant, the mock up.
- 5. Mel been in contact with Parks at AWDC, they have said it was the wrong season to be planting wild flowers, they were unaware of the fruit bushes. SBL had not agreed to maintain hamble and AWDC had given advice but had not agreed to maintain.
- 6. A summary of grants given this year, SRWA-£250, Sompting FC £1200, and Family centre awaiting further information. Discuss was had to make easier to apply by merging the Small Grants Scheme and Action Fund.
- 7. Review meeting date set for 8th August when Jim returns off his holiday, email to be sent to all partnership for their input between 10am and 12 noon.
- 8. Christmas events were discussed, Trevor speaking to landlord to seek permission on outside Christmas tree. It was suggested that Alun would speak to SPC, regarding working with SBL joint Christmas events.
- 9. Jacqui has spoken to Sompting Village Primary School who are happy to have the credit union savers scheme. The bursar and a member of the PTA will oversee the running of the scheme. SBL will deposit a £5 into each individual who opens an account, with a regular saving bonus of £5 should the child deposit in 9 out of 12 months. The initial £5 will be tied into the account for 6 months, and the catchment area of the school. Each child who registers will receive certificate and saving pig.
- 10. Donations for minibus must be deposited into nationwide so we can keep an eye on costings
- 11. When outside groups use hub, this should be exclusive use and volunteers/paid employees should not be in hub after 1pm
- 12. Mark Johnson co-opted on to partnership, and onto communication committee.
- 13. Terms of reference to be looked at regarding partnership members frequently no showing for meetings and their removal off partnership.
- 14. Meeting to be arranged to discuss the purchase of Defibrillators
